that we are already seeing and feeling and will continue to experience in the future.

*Net zero means cutting greenhouse gas emissions to as close to zero as possible, with the remaining emissions re-absorbed by natural carbon sinks such as forests and oceans.

OUR EMISSIONS

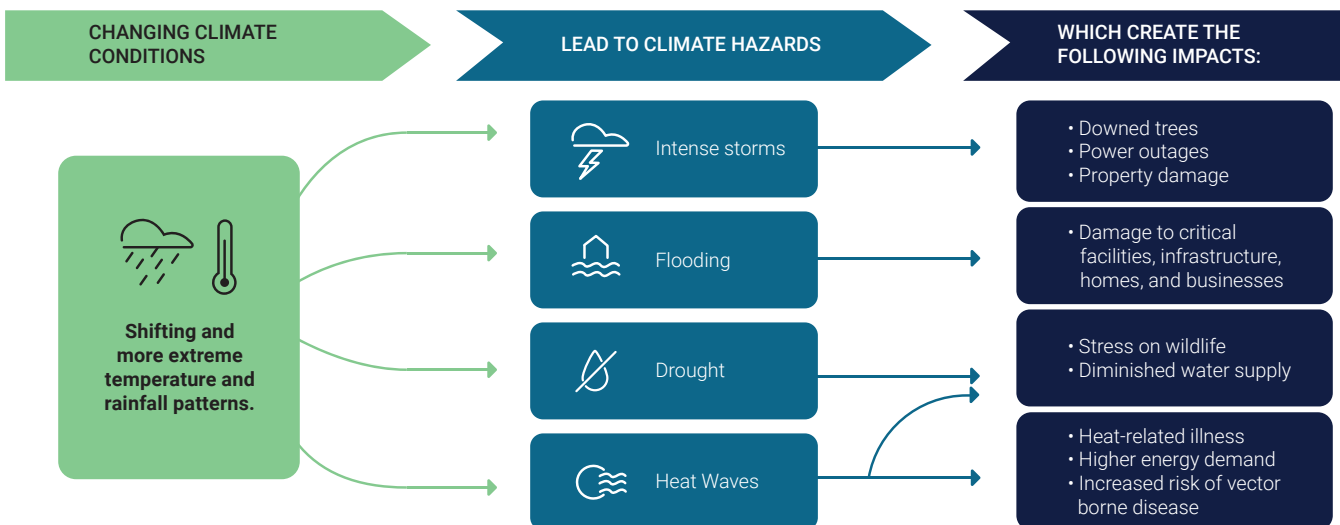
